The Australian Building Codes Board have recently published a new standard for Temporary Structures. The LSAA contributed to its development.

This Standard is intended for use in the design, construction and use of temporary structures. It provides criteria for structural safety (particularly determining appropriate wind actions), fire safety (including fire resistance of materials, fire safety services and equipment, and

It is still open for adoption by particular State or Territory Authorities.
